Warrantor (Fresco), warrants to the original purchaser of this air purifier, should it prove to be defective because of improper materials or workmanship (a) for 90 days from the date of original purchase. The warrantor shall provide the repair or replacement of the product without charge to the customer (b) For 5 years from the date of the original purchase, the warrantor, will repair any **defective part(s)** without charge for the part excluding plates, cord, and fuse holders. **The customer will be charged for labor, shipping and handling.** Warranty Restrictions (a) Opening the unit will void the warranty. (b) This warranty is invalid if the factory-applied serial number has been altered or removed from the product. (c) This warranty does not cover cosmetic damage or damage due to acts of God, misuse, abuse, negligence, or modifications of or to any part of this product. (d) This warranty does not cover damage due to improper operation or maintenance, connection to improper voltage supply, or attempted repair by anyone other than a facility authorized by Fresco Warranty Dept. To obtain warranty service, consumer must; (a) Provide proof of purchase, evidence unit is within the warranty period. (b) **Ship the unit freight prepaid**, in either its original packaging or packaging affording an equal degree of protection to Fresco Repair Dept. There is a **25% restocking** fee for units returned after 10 days.

The product should be delivered to the nearest Fresco Service Center by calling 865-850-4361. Transportation charges and shipping expenses are the purchaser's responsibility.

A unit returned for repair after the warranty period or a unit that shows damage, for which Fresco is not responsible, will be repaired for reasonable charge as determined by Fresco. There will be three attempts to advise the purchaser of the cost of repair or replacement before proceeding. After 90 days, if payment is not satisfied, the unit will be properly disposed.

THE OBLIGATIONS OF (Fresco) HEREIN ARE EXPRESSLY GRANTED IN LIEU OF ALL WARRANTIES, WHETHER EXPRESSED OR IMPLIED, INCLUDING BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE AND SHALL BE EFFECTIVE FOR 5 YEARS FROM THE DATE OF ORIGINAL PURCHASE OF THE PURIFIER.
